Institutions to fill the academic posts on the level of Skill Professor/ Skill Associate Professor/ Skill Assistant Professor in different fields and One non-academic post of Controller of Examination on deputation basis initially for the period of one year as per the details given below: -

General Instructions

1. The candidate must be citizen of India
2. Separate application form is required to be submitted offline for each post.
3. Knowledge of Hindi/Sanskrit up to matric level is essential.
4. The required qualification and relevant experience etc. for eligibility shall be determined as on the last date of receipt of application. The educational Qualifications and experience required for each post are enclosed at Annexure A
5. All qualifications must be attained from recognized Board/Universities/Institutes. The Candidates who have obtained qualifications from any Board/University/Institution declared fake or not recognized by respective regulatory bodies shall not be eligible for consideration for any of the post advertised. Qualifications obtained through distance mode are not admissible for teaching posts in science and technology.
6. If a Grade Point System is adopted the CGPA will be converted into equivalent marks. All the applicants need to enclose the supporting documents for conversion of CGPA into equivalent marks along with application form.
7. No TA/DA is payable for attending any test/ interview.
8. As per Ministry of Human Resource Development Notification No. 44 dated 01-03-1995 published in Gazette of India edition dated 10-06-2015, the Degree obtained through open Universities/ Distance Education Mode needs to be recognized by Distance Education Council, IGNOU. Accordingly, unless such Degrees had been recognized for the period when the candidates acquired the relevant qualification, they will not be accepted for the purpose of Educational Qualification.
9. Application not supported with required self-attested copies of certificates/ testimonials will be rejected. Incomplete applications or the applications received without the prescribed fee or received after the last date of receipt of applications will be rejected and no correspondence will be entertained in this regard. All the enclosed documents should be page numbered and self-attested.
10. A candidate found ineligible at any stage of selection/ norms his/ her candidature will summarily be cancelled. The prescribed essential qualifications and experience indicated are bare minimum and mere possession of the same will not entitle any candidate to be called for written test/ teaching skill/ interview.
11. University may conduct written test/ skill test for shortlisting candidates, if required.
12. The vacancy may be increased or decreased at the discretion of the University at the time of selection. The University reserves the right not to fill the post advertised without assigning any reason.
13. The period of experience wherever prescribed shall be counted only after obtaining the prescribed essential qualification. The experience certificate in support of the experience wherever prescribed should clearly reveal about the period of work, designation with pay scale/ pay band with grade pay/ pay level. The certificate must be supported with salary slip/PF statement/ Form 16/ Bank Statement or any other valid proof of salary paid as claimed in the certificate. (Annexure-B).
14. The proof of peer reviewed/refereed/ UGC listed journal status, /SCI Journals / Thomson Reuters impact factor, authorship claim etc. should be provided with a valid document along with application form. Also, the legible copy of claimed research papers should be enclosed with the application. University will not be responsible for any mistake in score due to not providing valid proof.
15. Concealment of facts or supply of wrong information will result in cancellation of candidature at any time in addition to legal action.

16. The Candidates are advised to keep on visiting the website of the University for related updates including any corrigendum/addendum, date of test/ interview/ list of shortlisted candidates etc. Further, no information in respect of this advertisement shall be published in the newspaper.
17. No correspondence what so ever will be entertained from the candidates regarding conduct/ result of Interview and the reason for not being called for Interview.
18. For all posts/positions which are sub-judice before Hon'ble Court through Writ Petitions, the final selection will be as per the final outcome of Writ Petitions.
19. Kindly note that merely appearing in an interview shall not confirm any right of appointment/ selection.
20. Candidates already working in Central/ State Govt. Universities/ Institutions etc. and fulfil the eligible conditions for the various posts as per the criteria in the advertisement may only apply for the posts against deputation basis.
21. A candidate who is already in service shall submit the application through proper channel along with vigilance clearance certificate from the competent authority. However, the candidate may send an advance copy of the application and in case the application is not forwarded due to whatever reasons till the time of written test or interview, as the case may be, the candidate, should produce a "No Objection Certificate" along with the "Vigilance Clearance Certificate" in a sealed cover from the employer at the time of interview, failing which candidature of the candidate will not be entertained & will not be allowed to appear in the interview. 22. The application for appointment on deputation shall be forwarded by the employer along with the Annual Performance Appraisal Reports (APARs)/ ACR for the preceding five years and Vigilance Clearance Certificate, duly certified by the Competent Authority (Annexure-D)
23. The period of Deputation will be for initially for a period of one year which may be extended up to three years Provided that the University reserve right to repatriate any such employee at any stage without assigning any reason.
24. The terms and conditions of deputation will be as per the rules of the University/ Haryana Govt. Rules.
25. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issuing the appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the applicant in this regard.
